Build a Legacy with Your Gift

DONATION

A simple donation indicating that your tax-deductible donation is for the HBVLE.

BEQUEST BY WILL OR TRUST

This is the most well-known and popular charitable planning vehicle.

BEQUEST OF RETIREMENT PLAN OR IRA BENEFITS

Retirement plans are an excellent way to accumulate assets for your retirement years, but are ineffective method of passing those assets to children or other heirs. These retirement assets may be reduced by more than 70 percent due to both estate and income taxation.

When you name HBVLE as the charitable beneficiary of the unused portion of your retirement assets, you reduce this tax burden and build a legacy.

LEAD TRUST

Transfer wealth to children and grandchildren after a period of years, with little or no estate or gift taxation, when you direct the trust to pay a portion of the income to HBVLE for the term.

A tax exempt trust pays HBVLE a set income at a stated rate or amount for life or a designated number of years. Assets placed in trusts may qualify for a partial income tax deduction, can be reinvested tax free, and often avoid estate taxation as the trust assets pass to HBVLE and other named charities when the trust terminates. Donors may appoint or serve as their own trustee.

LIFE INSURANCE

HBVLE can be named as the beneficiary of a paid-up policy.

LIFE ESTATE AGREEMENT

Donor deeds home or other property to HBVLE, receives a tax deduction, but retains the right to use the property for life.

BENEFITS OF ENROLLMENT

By informing HBV of your plans, you automatically become a member of the HBVLE Legacy Society. HBV will recognize your intentions and vou will be invited to attend special HBV events.
